Dear Mr. Anderson:

On July 12, 2004, the Texas Lottery Commission (the "Commission") received your email requesting an advisory opinion related to the definition of a "trust organization." Below is your question followed by the Commission's response.

Please refer to the term of "Trust Organization" utilized (sic) an application for a bingo license renewal – can a Home Owners Association (deals with deed restrictions, etc.) incorporated as a Non-Profit Texas Corporation fit the legal definition of a "Trust Organization."

ANSWER:

Texas Occupations Code §2001.059(a) provides the following:

A person may request from the commission an advisory opinion regarding compliance with this chapter and the rules of the commission.

Neither Texas Occupations Code Chapter 2001 (the Act), the Commission's charitable bingo rules, nor the renewal application for a license to conduct charitable bingo contain the terms "trust organization" or "home owners association." Consistent with the statute

cited above, a request must relate to compliance with the Act or Commission rules. Because your question does not relate to the Act or rules, it does not fall within the statutory parameters established for advisory opinion requests. Therefore, the question presented is not a proper subject for an advisory opinion under Texas Occupations Code §2001.059(a).

Texas Occupations Code §2001.059(a) provides that a person may request from the commission an advisory opinion regarding compliance with this Texas Occupations Code chapter 2001 and the rules of the commission. A request for an advisory opinion related to the definition of "trust organization" is not a proper request because the term "trust organization" is not included in the bingo statutes, rules or renewal application for a license to conduct bingo. A request must be in regards to compliance with the Act and the rules of the Commission. Therefore, this request does not fall within the scope of Texas Occupations Code §2001.059(a).
