Re: Conduct of Bingo

Dear Mr. Johnson:

This advisory opinion responds to your request which was received by the Texas Lottery Commission (Commission) on July 20, 2006. You requested an opinion about whether Tex. Occ. Code § 2001.411 permits an active auxiliary member of a licensed authorized organization to be the operator on duty during a bingo session.

ANSWER:

Tex. Occ. Code § 2001.411(b) provides that "[o]nly an active member of a licensed authorized organization may be an operator responsible for conducting, promoting, or administering bingo." Paragraph (c) of § 2001.411 permits "a member of an organization that is an auxiliary to the licensed authorized organization" to "assist in conducting, promoting, or administering bingo" Thus, an active auxiliary member may not be an operator responsible for conducting, promoting, or administering bingo.

SUMMARY

A member of an organization that is an auxiliary to the licensed authorized organization

may not be an operator responsible for conducting, promoting, or administering bingo.
