Adoption of Revised Commission Policy P-002 – Division of Responsibilities

Staff recommends that the Commission adopt revisions to Policy P-002, "Division of Responsibilities", with several minor changes to the existing language (redline version attached). This document addresses the policymaking responsibilities of the Commission and management responsibilities of the Executive Director and agency staff, as required by the Commission's 2013 sunset legislation codified at Texas Government Code section 467.037. It is scheduled for review and re-adoption this year. The Commission last adopted revisions to this policy in December 2018. The policy states that the Commission, with the advice and recommendations of the Executive Director and the Director of Bingo Operations (Bingo Director), shall establish general policies governing the operation and administration of the lottery and regulation of charitable bingo. Further:

- The Executive Director has broad authority to implement the Commission's general policies for the lottery by establishing specific policies, procedures and practices governing the day-to-day operation and administration of the lottery, including the activities of all divisions other than the Charitable Bingo Operations Division (CBOD) and internal audit activities.
- The Bingo Director shall implement the Commission's general policies for charitable bingo by establishing specific policies, procedures, and practices governing the day-to-day management of the CBOD.
- The Executive Director, as administrative head of the agency, has decision-making authority in certain agency matters that affect all Commission employees, including CBOD employees.

The Commission retains full authority to review and modify any specific policies, procedures and practices established by the Executive Director or Bingo Director. The proposed changes clarify that the Commission does not approve formal agency procedures.

<u>Recommendation:</u> Staff recommends that the Commission adopt revised Policy P-002, effective June 10, 2021.

The Commission shall ensure bingo and lottery games are conducted fairly and in compliance with the law. Accordingly, the Commission, with the advice and recommendations of the Executive Director and the Director of Bingo Operations, shall establish general policies governing the operation and administration of the lottery and the regulation of charitable bingo. The Commission retains full authority to review and modify any specific policies, procedures and practices established by the Executive Director for the lottery and the Director of Bingo Operations for charitable bingo.

The Commission shall employ an Executive Director to administer Texas Government Code Ch. 467 and the State Lottery Act. The Executive Director holds office at the will of the Commission.

The Commission's Policymaking Responsibilities. The Commission's policymaking responsibilities include, but are not limited to, consideration of and action on (i) administrative rule proposals and rule adoptions, (ii) the status and entry of enforcement orders, (iii) the agency's operating budget, (iv) major procurements as defined by agency rule, (v) agency policies certain formal agency procedures (e.g., Lotto Texas jackpot estimation), (vi) agency personnel matters, including but not limited to personnel matters regarding the positions that report directly to the Commission (the Executive Director, the Director of Bingo Operations, and (if applicable) the Internal Auditor), and (vii) providing direction to the General Counsel, other Commission staff, and the Office of the Attorney General and/or other outside counsel regarding pending or contemplated litigation involving the Commission. In addition, the Commission has authority to review and modify any specific policies, procedures and practices established by the Executive Director or the Director of Bingo Operations.

# 2. The Executive Director

The Executive Director is the administrative head of the Texas Lottery Commission. As authorized by the State Lottery Act, the Executive Director shall perform all duties required by the Commission to administer Texas Government Code Ch. 467 and the laws under the Commission's jurisdiction, including the State Lottery Act. The Executive Director may not hold other employment. The Executive Director shall implement the Commission's general policies for the operation and administration of the lottery, and may establish any specific policies, procedures and practices necessary for the effective and efficient operation and administration of the lottery.

The Executive Director shall employ a director to oversee each Commission division, with the exception of the Director of Bingo Operations and the Internal Auditor, who report directly to the Commission. A division director serves at the will of the Executive Director. The Executive Director may delegate signing authority relating to certain actions and responsibilities to division directors. The Executive Director also may delegate his or her authority to a division director or other management employee, who may act as Executive Director in the absence of the Executive Director.


