The petitioners are licensed bingo distributors and they submitted the petition on July 5, 2022. The proposed rules would address the use of shutter card bingo systems, which is an authorized form of bingo using shutter cards, with the use of shutter card bingo site systems and customer accounts for the play of bingo.

Under the Texas Administrative Procedure Act, the Commission rules, both within 60 days after the date a petition is submitted, the agency is required to either deny the petition in writing, stating its reasons for the denial, or initiate a rulemaking proceeding.

The 60th date in this case is September 3rd, so this is the last meeting for the Commission to act. We have discussed this matter internally with the Bingo Director and recommend that the Commission vote to initiate a rulemaking proceeding. The Bingo Advisory Committee at their last meeting also voted to recommend initiating a rulemaking proceeding.

If the Commission agrees, staff will take the petition and put it into the required Texas

Register format and bring it back for your consideration to publish for public comment at a future meeting.
