TERMINAL UPDATES

- The Altura sign on screen now has 9 digits for your Retailer Number (ID). If your ID is 8 digits, just add a "0" at the beginning. Ex. 0123456-00
- All draw game tickets produced at the Altura terminal must be scanned with the hand-held barcode scanner for validation, inquiry and cancellation.

FREQUENTLY ASKED QUESTIONS

Q. Is it against the law to sell tickets to a person under the age of 18?

 Yes. It is an offense (Class C misdemeanor) to knowingly sell or offer to sell a lottery ticket to a person younger than 18 years of age. Also, if a person younger than 18 years of age purchases a lottery ticket, they are committing an offense. Retailers must verify age before conducting lottery transactions.

Q. What do I do if I think a minor is attempting to purchase tickets at the lottery self-service vending machine?

A. Every retail location equipped with a lottery self-service vending machine is provided with a remote shut-off device to disable the machine and control sales transactions. Remember, you may only conduct lottery transactions with players 18 and older.
