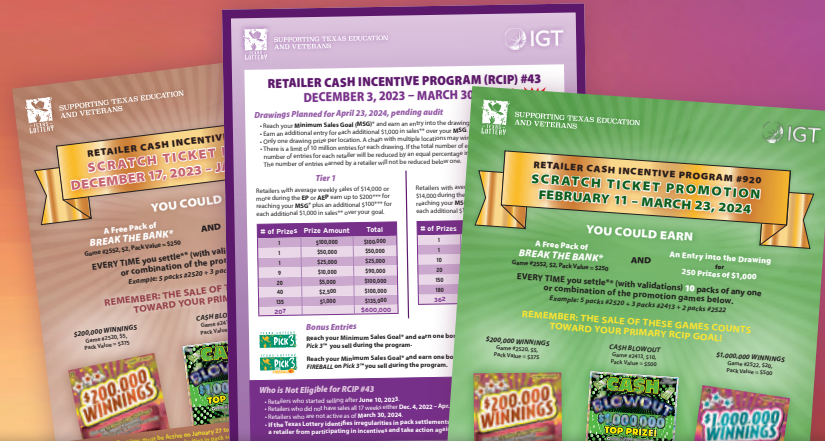

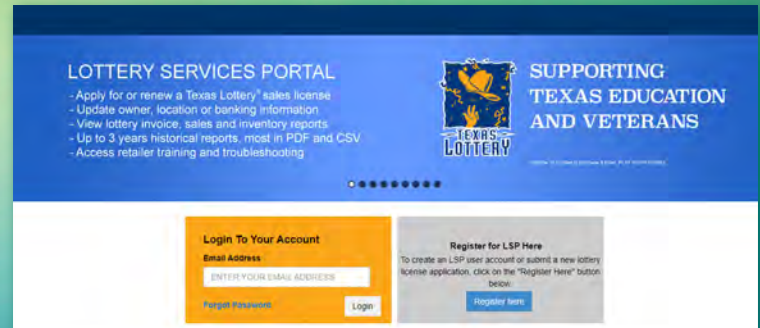
## LOTTERY SERVICES PORTAL (LSP)
