Texas Department of Licensing and Regulation is issuing this Request for Proposals (RFP) to solicit proposals from interested vendors to perform a comprehensive review and evaluation of security for the Texas Lottery Program for the Texas Department of Licensing and Regulation (Security Study), including, cyber security, computer security, systems security, and all aspects of lottery security in accordance with the State Lottery Act, Tex. Gov't Code Ann. ch. 466, specifically §§ 466.020(e) – (f) and Texas Administrative Code, Title 1, Part 10, Chapter 202 and Chapter 2054, Government Code, Section 2054.515, and Tex. Gov't Code §2063.303, 2054.137 and 2054.161.

The Texas Lottery is required to employ an independent firm to conduct a Security Study at least once every two years.

The purpose of the Security Study is to evaluate the security and integrity of the games and operation of the Texas Lottery Program. This security study involves, but is not limited to conducting an assessment of the agency's information resources systems, network systems, digital data storage systems, digital data security measures, and information resources vulnerabilities of the Texas Lottery Program, the Texas Lottery Program's lottery operator vendor (Brightstar Global Solutions Corporation), the Texas Lottery Program's instant ticket manufacturers (Scientific Games LLC, Pollard Banknote Limited Partnership and Brightstar Global Solutions Corporation), and other agency services contracts/vendors of the Texas Lottery Program.
